MINUTES - TRI-TOWNSHIP PARK DISTRICT

The regular monthly meeting of the Tri-Township Park District board of Commissioners was convened at the Pavillion meeting room on April 21, 1981 with president Russell Wiesemeyer presiding. Commissioners answering present to the roll call were Arth, Foucek, Langenwalter, Leonard and Wiesemeyer. Attorney Cadagin, Roy Lee, Mike Scroggins and Howard Woods were also present.

Mike Scroggins approached the Board on belalf of the Triad baseball team to confirm reservation for May 14, 1981 for the large baseball diamond.

Roy Lee stated his concern avout the condition of the backstop on the large ball diamond.

A discussion on the purchase of bleachers for the large ball diamond followed. The Board reviewed several offerings from different companies. Motion was made by Commissioner Foucek to purchase four sets of fifteen foot, five row aluminum bleachers with hot dipped galvanized frames from Bergfield Recreation, Inc. for \$2,712.00. Motion was seconded by Commissioner Langenwalter and carried. Mr. Lee agreed to contact Lanahan Construction for a bid on rehabilitation of the dugouts.

Commissioner Wiesemeyer advised the Board that he had received a call from Dwayne Zobrist, homecoming committee chairman, concerning lighting in the Park. Although no request was made to use the Park for the Homecoming activity, there is a strong possibility that a future requirement may exist.

Attorney Cadigan informed the Board that there is a portion of the roadway to Route 162 that has been dedicated to the City. However Commissioner Leonard reported that the City has no record of this. Attorney Cadagin will check with the City Attorney on the matter.

Commissioner Wiesemeyer adivsed the Board that Attorney Terry Francis had offered to donate some vacant lots in the High Meadows subdivision to the Park. The Board vetoed the offer in view of additional caretaker expense.

Tim Schnoeker's name was submitted as a candidate for helper to Mr. Semanisin. Commissioner Arth moved to hire Tim at the minimum wage, confirmation of which will be researched by Attorney Cadagin. Motion was seconded by Commissioner Foucek and carried.

Commissioner Wiesemeyer suggested that the lake could be stocked with fish. The possibility of assistance from the Conservation Department will be researched on this matter.
