Plans are coming along for the Fourth of July celebration. The certificate of insurance is here. Plans for homecoming are also coming along well and the certificate of insurance has been ordered.

Athletics:

The diamonds are ready for use each day. It was decided to cap the rest of the fence around the baseball field. Italiano is to work on keys for the select teams.

Special Construction Projects:

There will be a fund raiser on June 15. Work on the sidewalk should start soon.

Director's Report:

Greenfield reported on a planned parade to mark the beginning of the soccer season.

The drinking fountains are being repaired.

It was decided to update an agreement with the Troy Lions Club concerning the storage building (Byrne, Simpson 5-0).

The patchwork repair of the tennis courts should be completed soon. The Sport Court has been ordered.
