Elections – The paperwork is available for candidates to pick up.

MEPRD Grant – Phil asked Terry and Randy to work with him to develop a chronological recap and list all of the events of the I55 overpass walkway request and then the subsequent trail grant.

Madison County Grant – Phil said that he learned this grant will be for \$3 per person in the district, or about \$40,000. This grant application will be for a playground and picnic shelter for the Meadow Drive Park.

Picnic Table Grant – Phil said he has learned this is once again available and will be for up to \$10,000 with a 20% match. Phil said this amount would buy approximately 20 new picnic tables. We have older fiber glass tables left than that the need to be replaced.

Motion: Approve modified working budget \$50,000 skateboard park. Randy/Jim 5-0 Ayes

Motion: Approve execution of agreement to hire Luallen, Clearlock, and Barth for audit and to execute letter of engagement. Terry/Randy 5-0 Ayes

Motion: Recognize Phil Loethen, Dave Roady, Tim Greenfield, and Norm Beck as authorized for check signing and to remove Doug Brendel and Mary Kmetz. Randy/Jim 5-0 Ayes

All-Purpose Erectors replace baseball electrical panel – still working on.

Phil presented the information for the upcoming tax levy. **ATTACHED**. We are estimating the EAV will increase by 9.36% (the average of the last three years) and will reduce the tax rate by 4.2%, resulting in an increase of revenues of approximately 4.9%. A public meeting was not required.

Motion: Approve Ordinance 2004-08 2005 tax levy. Terry/Jim 5-0 Ayes

Phil noted that this is the 4th year in a row that the Park has had a reduction of the tax rate. The total reduction over that timeframe is 17.6%.

Phil said that the plaque for Rollie's Room was presented in Zelda Reiss at a Senior Dinner. Phil said that he believed Zelda was very pleased.

Athletics - Norm

In Norm's absence, Phil said that we have 83 people signed up for the volunteer dinner and he is planning on ordering for 95. Phil noted that it is important to recognize volunteers like the TBSL, TSC, Titans, FOP, the Lion's, and others if we hope to keep them coming back and doing good things for both the park and the community.

<u>Grounds – Jim Derby</u> Nothing to report.

Special Events - Joe Eader

Motion: Approve use of the maintenance shed for Cub Scouts Pinewood derby Sat 12/18, Wed 12/129 (6-9PM), and Sat. 1/15. Joe/Terry 5-0 Ayes

Motion: Approve free use of the Wiesemeyer Center (upper and lower levels for Saturday and Sunday (Feb 19 and 20) for a coed scout lock in. Joe/Terry 5-0 Ayes

Phil said that in the last year, we have seen significant free usage of the Wiesemeyer Center on many weekend dates by many local scout troops and groups. Joe said he would work to recommend a policy restricting free weekend usage to a manageable number that would allow the scouts the time that they need and still allow the Park to utilize the Center for the purpose of generating revenue on the weekends. Year-to-date, rental income at the Wiesemeyer Center is down a little over \$9,000.

Personnel & Safety - Terry

Terry presented a proposed bid specification for the Skateboard Park and asked for input from the board.

Joe said that we should require slab design specs, equipment specs, and warranty information if applicable.

Jim said that we would want the grading and slope plans for the concrete.

Joe said that we should require 3-4 inches of rock base and at least 4 inches of reinforced concrete. This requirement should be followed with the statement that we would accept whatever is deemed suitable for their equipment.

Terry said that he would make these changes and fax out the bid specs the next day.

Phil said that he would work to place the bid notice in the required two daily papers.

Terry said that the bid plan called for a bidders meeting on January 5th, and bids to be turned in by January 12th. The board would accept them later on that same date at the regular meeting. This gives the park/city committee two weeks to decide on what best to go with and then a recommendation will be made on which bid to accept at a special meeting to be held January 26th. Bid specifications require that the job be completed at a maximum of 60 days after acceptance. This means the project will be completed by the end of March, about a week prior to the general election.

Motion: Approve letting out bid specifications for skateboard park. Terry/Joe 5-0 Ayes

Motion: Approve the park paying for half of Tim Greenfield's health insurance out of the general fund. The park will withhold the other half of Tim's health insurance in pre-tax dollars. The park will make the entire payment to Tim's health insurance carrier. Terry/Randy 5-0 Ayes
