## Playground -

Phil said that the contract is signed, the colors accepted, and the bench has been added. We are shooting for installation around the second week in May.

## Fertilize grass -

Phil said that we have a cost only bid for fertilizer and weed and feed from Troy Grain. Phil also noted that Troy Grain never charges the park for all the feed that is donated to the petting zoo.

Terry said that as much as he appreciated their kindness and civic spirit he wished they would put a little profit into their bid so that we could repay them at least a little.

Motion: Accept Troy Grain offer of \$3,750 for fertilizer (12-12-12) on 32 acres and weed and feed on existing 55 acres. Randy/Norm 7-0 Ayes
