Meeting called to order at 7:00 by Phil

### Roll call:

## Skateboard Park Bid Opening -

Bids were received from the following vendors:

- 1) Howard White & Associates 2 proposals @ \$110,000 each
- 2) Illinois At Play 3 proposals @ \$110,000 each
- 3) Midwest Sales Co. 1 proposal @ \$110,000 with option of \$114,000 phase II
- 4) Fry & Associates 2 proposals @ \$110,000 each
- 5) Riverbend 1 proposal @ \$109,425
- 6) Mountain Ramp 3 proposals @ \$100,116, \$102,267, and \$108,504
- 7) Tru Ride 2 proposals for equipment only \$51,945 and phase II @ \$88,316
- 8) Recreation Concepts 3 proposals @ \$110,000 each

Terry said the plan now was for the skateboard committee to meet as soon as possible and review the proposals. After narrowing down the 15 to a smaller number, the committee will then attempt to meet with local skateboarders and ask for input and advice from them relative to making a final recommendation. This recommendation will them be made to the Park Board at the January 26<sup>th</sup> meeting.
