

ORDINANCE NO. 1967-3

AN ORDINANCE MAKING A TAX LEVY FOR THE
TRI-TOWNSHIP PARK DISTRICT IN THE COUNTY OF
MADISON AND STATE OF ILLINOIS FOR THE FISCAL YEAR
BEGINNING APRIL 1, 1967 AND ENDING
MARCH 31, 1968

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE
TRI-TOWNSHIP PARK DISTRICT:

ARTICLE I. This this Ordinance be and the same is hereby
termed the Annual Tax Levy Ordinance for the Tri-Township Park
District in the County of Madison and State of Illinois.

ARTICLE II. That there be and is hereby levied and assessed
upon all the real and personal property situated within the corporate
limits of the Tri-Township Park District in the County of Madison
and State of Illinois, the sum of Eight Thousand Dollars (\$8,000.00),
which said amount shall be raised by taxation upon all assessed
property according to its value as the same is equalized or assessed
by the Department of Revenue for the year A. D. 1967, and which said
amount is to defray the expenses of the Tri-Township Park District
as provided by the annual Appropriation Ordinance beginning April 1,
1967 and ending March 30, 1968, as provided by Ordinance No. 1967-2
of said Tri-Township Park District passed and approved on the 22nd
day of May, 1967, duly published according to law by publication
thereof in the Troy Tribune, a newspaper of general circulation
within the said Park District on the 13th day of June, 1967, all of
which was done by the Secretary of said Tri-Township Park District,
and which said Ordinance is now on file with the Secretary of the
Tri-Township Park District; the said Tax Levy being in detail
as follows:
