### ORDINANCE No. 1971--2

AN ORDINANCE MAKING APPROPRIATIONS TO DEFRAY
ALL NECESSARY EXPENSES OF THE TRI-TOWNSHIP PARK DISTRICT
AND OF THE BOARD OF COMMISSIONERS OF THE SAID PARK
DISTRICT, MADISON COUNTY, STATE OF ILLINOIS, FOR THE
FISCAL YEAR BEGINNING APRIL 1, 1971, AND ENDING
MARCH 31, 1972.

Be it ordained by the Board of Commissioners of the Tri-Township Park District, Madison County, Illinois:

# ARTICLE I

That the following sums of money, or as much thereof as may be authorized by law, as may be deemed necessary to defray all necessary expenses and liabilities of the Tri-Township Park District, be and the same are hereby appropriated for the corporate purposes and objects of said Park District, as hereinafter specified for the fiscal year beginning on April 1, 1971, and ending on March 31, 1972.
