PARK DISTRICT IN THE COUNTY OF MADISON AND STATE

OF ILLINOIS FOR THE FISCAL YEAR BEGINNING

APRIL 1, 1995, AND ENDING MARCH 31, 1996

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF TRI-TOWNSHIP PARK DISTRICT:

ARTICLE I: That this Ordinance be and the same is hereby termed the Annual Tax Levy Ordinance for the Tri-Township Park District in the County of Madison and State of Illinois.
