ORDINANCE #2019-04

AN ORDINANCE FOR THE LEVY OF TAXES FOR THE TRI-TOWNHIP PARK DISTRICT FOR THE FISCAL YEAR BEGINNING APRIL 1, 2019 AND ENDING MARCH 31, 2020

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TRI-TOWNSHIP PARK DISTRICT, COUNTY OF MADISON, STATE OF ILLINOIS, AS FOLLOWS:

SECTION1. That the sum of Nine hundred ninety thousand, twenty three dollars (\$990,023.00) being the total of that part of the appropriations heretofore legally made which are to be raised by taxation for the current fiscal year beginning the 1st day of April 2019 and ending the 31st day of March 2020, by Tri-Township Park District for all corporate purposes of said Park District and for purposes of providing for a General and Recreational Fund, Insurance Fund (Liability and Workers Compensation), Audit Expense Fund, Illinois Municipal Retirement Fund, Social Security Fund, Liability and Worker Compensation, be and the same is hereby levied upon all taxable property within said Park District subject to taxation for said fiscal year.
