# AN ORDINANCE FOR THE LEVY OF TAXES FOR THE TRI-TOWNHIP PARK DISTRICT FOR THE FISCAL YEAR BEGINNING APRIL 1, 2020 AND ENDING MARCH 31, 2021

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TRI-TOWNSHIP PARK DISTRICT, COUNTY OF MADISON, STATE OF ILLINOIS, AS FOLLOWS:

SECTION1. That the sum of One million fifteen thousand one hundred eighty five dollars (\$1,015,185.00) being the total of that part of the appropriations heretofore legally made which are to be raised by taxation for the current fiscal year beginning the 1st day of April 2020 and ending the 31st day of March 2021, by Tri-Township Park District for all corporate purposes of said Park District and for purposes of providing for a General and Recreational Fund, Insurance Fund (Liability and Workers Compensation), Audit Expense Fund, Illinois Municipal Retirement Fund, Social Security Fund, Liability and Worker Compensation, be and the same is hereby levied upon all taxable property within said Park District subject to taxation for said fiscal year. The specific amount as levied for the various purposes mentioned above are as set forth, said taxes levied being for said current fiscal year of said District and for the said appropriations to be raised by taxation, the total of which have been ascertained as aforesaid, and being as follows:

SECTION 4. This Ordinance shall take effect and be in full force and effect immediately upon and after its passage and approval.
